Section 1. No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any officer, director, member or individual.

Section 2. It is intended by the provisions of these Articles of Incorporation that the corporation shall possess the status of an organization exempt from federal income taxation under the provisions of Section 501(c)(6) of the Internal Revenue Code, as now in force or as hereafter amended. Accordingly, no part of the affairs of the corporation shall be administered, directly or indirectly, in a manner whatsoever which might jeopardize the tax exempt status of the corporation. No substantial part of the activities of the corporation shall involve the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in, including the publishing or distributing of slates, any political campaign on behalf of any candidate for public office.

ARTICLE VIII BYLAWS

The Board of Directors of this corporation shall make and adopt the initial bylaws for the corporation. The bylaws shall prescribe the manner in which such bylaws may be altered, amended, or repealed and the manner in which new bylaws may be adopted.

ARTICLE IX CORPORATE MEMBERSHIP IN ASSOCIATION

The bylaws may provide that this corporation will be a member of or subject to the authority of a head, state or national association, organization, or corporation, provided that such entity is not for profit and shares the purposes of this corporation.

ARTICLE X STATEMENT OF PROPERTY

Upon its incorporation, the corporation shall take over any cash representing contributions and donations made prior to incorporation or any cash or assets held in the name of the Jacksonville Women Lawyers Association.

ARTICLE XI TERM OF THE CORPORATION

This corporation is to exist perpetually. In the event the corporation is dissolved, the outgoing Board of Directors shall distribute any assets remaining after the payments of all debts and charges of the corporation and expenses of dissolution to one or more properly incorporated organizations which share the purposes of this corporation and are tax-exempt within the meaning of Section 501(c)(6) of the Internal Revenue Code.
