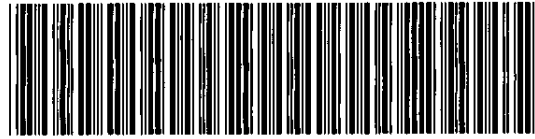

Pursuant to Chapter 617.020 of the laws of Florida, the undersigned, who are citizens of the United States, do hereby submit these articles of Incorporation for the purpose of forming a nonprofit religious corporation.

ARTICLE 1

The name of the corporation is Seafarer's Chapel, Inc.

ARTICLE 2

The corporation shall have a perpetual existence.

ARTICLE 3

The effective date of incorporation shall be the date filed with the Secretary of State.

ARTICLE 4

The corporation will not have members.

ARTICLE 9

The corporation does indemnify any directors, officers, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

ARTICLE 10

The corporation is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future federal law. Such purposes include, but are not limited to meeting the spiritual, emotional and physical needs of people through faith in Jesus Christ.

ARTICLE 11

Upon the dissolution of the corporation, after paying or making provisions for the payment of all legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed by a court of competent jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as court shall determine which are organized and operated exclusively for such purposes.
