To Whom it May Concern:

I found out that I was placed as Incorporator, Registered Agent and Treasurer of Five Fires Apostolic Ministries, Inc, Document no. N13000008382. This 501C3 Corporation was not set up by me, yet it allegedly bears my name and signature as the Incorporator. was also placed as Treasurer and Registered Agent without my knowledge and consent. I did not sign the documents accepting the appointment as Registered Agent. In fact, I have never used the name Michelle Daily, as that is not my name, and there is no such person by that fictitious name, residing at 6871 NW 70 Place, Parkland, Florida 33067.

Upon receiving correspondence to my home address, I looked up the Corporation and requested to be removed immediately when I saw that I was placed as Treasurer, Registered Agent and Incorporator and that my "signature" for the latter two had been forged. I never consented to any of this, or for the use of my home address to be used for this Corporation, as I do not use it in public documents and would like to have my home address removed from any affiliation with this Corporation immediately. Although I have requested to be removed from this Corporation, and was promised it would be done by March 19, have effort has been made by this Corporation to do so.

Upon ray inquiry, I was advised by the Division of Corporations that the only way for me to extricate myself from this 501C3, was for me to resign from the positions of Registered Agent and Treasurer, which I never held. It is unbelievable that I am forced to pay money and "resign" to get this matter undone. Your Department should have some

provision in place to protect victims from this type of fraud, instead of merely forcing them to pay in order to resign. Something needs to be done about this system which allows people's names to be added with a click of a button, and anyone can sign your signature to implicate you, without your knowledge or consent.

Nevertheless, attached please find my resignation as Treasurer and Registered Agent, effective immediately. Please also take my name and home address off as Incorporator. I do not want correspondence coming to my home address and I do not want to be held liable for any actions of this 501 C3 when I never accepted the office of Treasurer.
