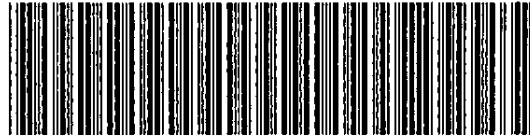

ARTICLE VIII Dedication of Exempt Assets

The property of this corporation is irrevocably dedicated to religious, educational, and charitable purposes and no part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its Directors, officers or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services and to make payments and distribution in furtherance of the purposes of the corporation

ARTICLE IX Dissolution Clause

Upon Dissolution of the Company, the Board of Directors shall, after paying or making provisions for the payment of all debts and liabilities of this corporation, distribute the remaining assets of the corporation to 501(c)(3) entities teaching the Roman Catholic faith prior to the corporation's dissolution.
