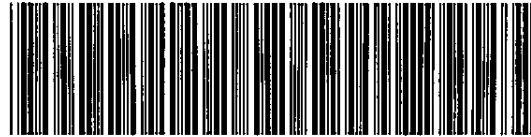

Section 2 Purpose / Amendment

This organization shall be operated as a nonprofit organization exclusively for the support of music education and as such, will support the following educational objectives: Cultural, Educational, Service, Citizenship, and Recreational.

This corporation is organized and operated exclusively for CHARITABLE and EDUCATIONAL purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable purposes of the marching band and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for Kathleen High School Band and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
