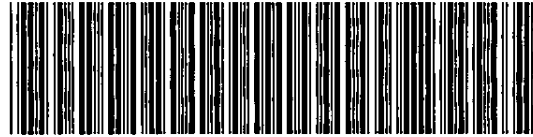

Rescue Threads, Inc. Educational activities include:


- Informing and increasing awareness within the public about fire safety issues.
