ARTICLE III – PURPOSE

- The organizational purpose of PIN Team, Inc. is to apply process improvement to non-profit organizations to increase efficiency, effectiveness, and safety of the operations of those non-profits.
- 2) No substantial part of the activities of PIN Team, Inc. shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall the corporation participate in or intervene in any political campaign on behalf of any candidate for public office.
- 3) PIN Team, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE VIII – DISSOLUTION

- 1) The property of PIN Team, Inc. is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
- 2) The manner of distribution of assets in this corporation's winding up is as follows: Upon dissolution of PIN Team, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal, state or local government for public purpose. Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
