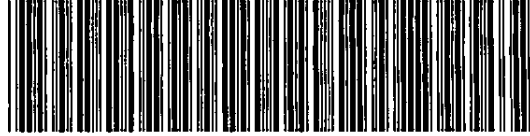

Articles of Amendment

Article one

The name of the corporation is **Fraternidad de Iglesias Independientes de Santidad Inc.** Incorporated on September 20, 2013 and receiving Certificate of Filing number **N130000084645**

Article two

The purpose of **Fraternidad de Iglesias Independientes de Santidad Inc.** Is to provide an organization for which non affiliated churches can unite and receive spiritual, educational, moral and fellowship support.

- 1) To preach and teach the word of God and to lift up the Lord Jesus as the Way, the Truth, and the Life.
- 2) To provide continuing education to Ministers and Christian workers.
- 3) To assist our churches in there promotion of the spiritual growth within believers.
- 4) To assist the teaching of believers to be witnesses of the Lord Jesus Christ, and leading others unto repentance for the remission of sins and into God's Holiness.
- 5) To provide a united front in the spreading of the gospel that sets the captives free, saves those that are lost, opens the eyes of the blind and preach the acceptable year of the Lord.

Article three

The business address of the principal place of business is 1230 South John Parkway, Kissimmee, Florida 34741. The street address of the registered office 338 Drake Elm Dr. Kissimmee, Florida 34743. The Registered Agent at such address is Jesús M. Morales of Osceola County.

Article four

Article 4 of the Articles of Incorporation is hereby amended so as to read as follows:

- a) Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3), of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

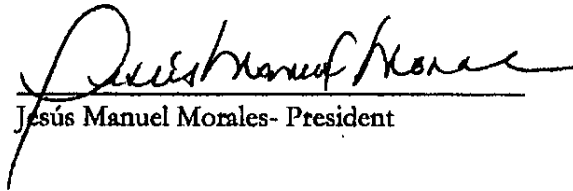

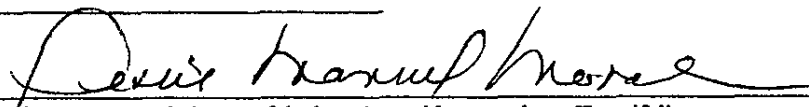
