**ARTICLE I
CORPORATE NAME**

**ARTICLE IV
GENERAL AND SPECIFIC PURPOSES**

Section I - General Purpose

RESCUE MIAMI OUTREACH, INC. is a Christian organization who ministers to all persons helping them with education, financial assistance, food, and instruction in the love of Jesus Christ. This will include ministering to those who are disenfranchised, homeless, abused, and imprisoned. We desire to assist all persons in need of job placement, tutoring, education and general assistance who are suffering spiritually, emotionally, socially and financially in our society.

The corporation is also organized to provide a learning experience for individuals, parents and children. It shall offer activities to teach them about Christian biblical principles, education, foster a sense of positive self-esteem, encourage social, emotional and physical skills and the creative abilities of the whole person in Jesus Christ. Our ministry will also help and assist individuals physical needs such as hygiene training, food, water and general nourishment.

We will additionally provide teaching material for pastors, churches, fellowship groups and conduct seminars to help strengthen the Body of Jesus Christ here and around the world.

Said corporation shall govern itself and will conduct all its own affairs according to the New Testament Scriptures. This shall include such matters as teaching, election of the Board of Directors and officers, and discipline on all business matters.

Said corporation will establish and maintain a place of help, education and loving assistance for Almighty God, our Heavenly Father, to provide Christian education, where the Holy Spirit may be honored according to our distinctive testimony. Our ministry will be available here and abroad.

Section II - Internal Revenue Service

Said corporation is organized exclusively for charitable, religious, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on

(a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or

ARTICLE V CORPORATE BOARD OF DIRECTORS AND OFFICERS
