ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MONTEREY AT HORIZONS WEST HOMEOWNERS' ASSOCIATION, INC.

Pursuant to the provisions of Section 617:1006 of the Florida Statutes, MONTEREY AT HORIZONS WEST HOMEOWNERS' ASSOCIATION, INC., a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is Monterey at Horizons West Homeowners' Association, Inc.
- 2. The original Articles of Incorporation for the Corporation were filed on September 30, 2013, and assigned Charter No. N.13000008841.
- 3. By the execution of a manimous written consent executed on November 7, 2014, the Corporation's Board of Directors have approved, authorized, and directed that Article I of the Corporation's Articles of Incorporation be amended and restated. There are no members entitled to vote on the amendment, and the amendment was adopted by the Board of Directors.
- 4. Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

For convenience, the corporation shall be referred to in this instrument as the "Association," these Articles of Incorporation as the "Articles," and the Bylaws of the Association as the "Bylaws."

Suite 410, Orlando, Florida 32839, or at such other place as may be subsequently designated by the Board of Directors.
