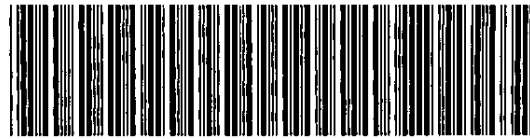



ARTICLE I NAME

The name of the corporation shall be: Ann M. Scollay Education Charity, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: Ann M. Scollay Education Charity, Inc. is organized exclusively for charitable purposes under section 501(C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code to provide financial scholarships to nursing students enrolled at Indian River State College, Florida.
