The undersigned President of THE SOUTH FLORIDA SHOMRIM SOCIETY GROUP INC., executes these Restatement of Articles of Incorporation of THE SOUTH FLORIDA SHOMRIM SOCIETY GROUP INC., pursuant to Chapter 617 of the Florida Statutes.

#### ARTICLE 1 - NAME

The name of the Corporation is THE SOUTH FLORIDA SHOMRIM SOCIETY GROUP INC., (hereinafter, "Corporation").

#### ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE 3 - PROHIBITIONS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Second hereof. distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Restatement of Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE 4 - ADOPTION**

These Restatement of Articles of Incorporation were adopted on 24 July 2014, and the number of votes cast by the Members for the Amendment of the Restated Articles of Incorporation was sufficient for approval.

#### ARTICLE 5 - PRINCIPAL OFFICE

Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
