<u>Purpose</u>: The GFWC Woman's Club of Macclenny shall be organized and operated exclusively for charitable, religious, scientific and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future tax code) and shall otherwise comply with any requirements for classification as an exempt entity under such section.

<u>Dissolution</u>: Upon the dissolution of the GFWC Woman's Club of Macclenny, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the federal government or to a state or local government, for a public purpose.
