

AMERICAN-NOW! INC (EIN#47-3340944) The corporation shall operate exclusively for charitable and education purposes under section 501(d (3) of the Internal Revenue Code as follows:

To maximize and accelerate, the contribution of new Americans.

Article IX

No part of the net earnings of this corporation shall inure to the benefit of , or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organizations shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contribution to which are deductible under section 170(c) (2) of the Internal revenue Code, or corresponding section of any future federal tax code.

Article XII

Upon the dissolution of the c corporation, assets shall be distribution for one or more exempt purposes within the meaning of section 501 (c (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose.
