AMENDMENT OF ARTICLES OF INCORPORATION

Comes now, Lake City Citizens Police Academy Alumni Association, Inc., and after notice to the membership of a meeting to Amend the Articles of Incorporation of a meeting held on the 15th day of September, 2015, the membership voted by at least two thirds of the voting members to amend the Articles of Incorporation.

The amendment to the Articles of Incorporation is to add:

ARTICLE X

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
