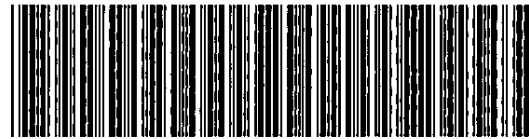

ARTICLE III PURPOSE
