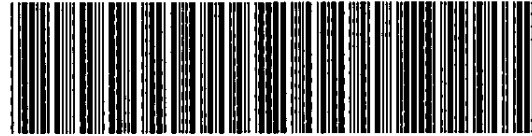

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: exclusively for educational and charitable purposes within the meaning of Section 501(c)3 of

IRS Code of 1986 or the corresponding section of any future tax code. Calliste Ministry for Grenada is a hunger relief organization formed to combat hunger and its health issues

by providing food, toiletries and medical supplies to the disadvantaged and poor in communities of Grenada. The Corp collects manufacturer's coupons,

shops, distributes items and educates the underprivileged on how to stretch their limited food dollars. No part of the activities of the Corps shall be

carrying on propaganda or otherwise attempting to influence legislation, or participating in or intervening in any political campaign on behalf of any

candidate for public office. The Corp shall not carry on any activities not to be carried on by a Corp exempt from federal income tax under 501(c)3 of the IRS Code,

or by an organization where contributions are deductible under Section 170(c)2 of the IRS Code, or any corresponding section of any future tax code.

The manner in which the directors are elected and appointed: Shall be elected or appointed

in a manner & terms specified in the bylaws; to serve a 2 year term, to begin January 1 and end December 31.

Article VIII No Part of the net earnings shall benefit any officer the Corp. Upon the dissolution of the Corp the board of directors shall, after paying or making provision for payment of all liabilities of the Corp: dispose of the residual assets of the Corp to one or more organizations which are exempt under Section 501(c)3 of IRS Code of 1986 or future IRS Code. Any such assets not disposed of shall be disposed of by the Superior Court of the County in which the principal office is located in, for such purposes or organizations that the court determines.

ARTICLE IX Mary L. Calliste will be the registered agent of Calliste Ministry for Grenada Inc and is authorized to receive and sign legal papers on behalf of the corporation.
