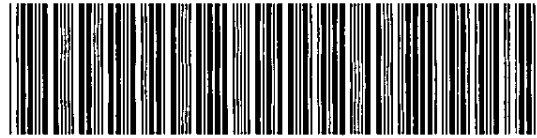

The name of the corporation is Geronimo Research, Education and Training, Inc. The document number of the corporation is N13000009126.


**ARTICLE II**
