

ARTICLE III is amended to read as follows:
To promote professional and personal evolution, development, and health in the individual, family, organization,
and community by offering and financially supporting integral and ontological training at workshops, retreats,
events, online courses, podcasts, and electronic publishing. Notwithstanding any other provision of these articles,
this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that
are not in furtherance of the purposes of this corporation.
Article IX is added to read as follows:
Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within
the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code,
or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets
not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office
of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall
determine, which are organized and operated exclusively for such purposes.
