The undersigned subscribers to these Articles of Incorporation, all natural persons competent to contract, hereby associate themselves together to form a membership-based nonprofit corporation under the laws of Florida.

ARTICLE I

NAME

The name of this corporation will be, IGLESIA JESUCRISTO ROCA FUERTE, INC.

ARTICLE II

Principal headquarters

Iglesia Jesucristo Roca Fuerte will have its headquarters at 10530 Taylor Rd Thonotosassa, Fl. 33592.

ARTICLE III

PURPOSES

This corporation is organized exclusively for charitable, educational, religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax codes). This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future tax code). It will invest its monies and assets within the scope of Florida none profit laws.

ARTICLE IV

TERM

The term for which this corporation shall exist shall be perpetual. Its directors shall be elected and appointed by the congregation as established in by-laws of IGLESIA JESUCRISTO ROCA FUERTE
