Pursuant to Chapter 617 of the Florida Statutes (Not for Profit).

ARTICLE I - NAME

The name of this corporation is FRIEDRICHS DOBERMAN RESCUE, INC.

ARTICLE II – PRINCIPLE OFFICE

The principal place of business of this corporation is 18800 US Highway 301, Dade City, Florida 33523. The mailing address of this corporation is 18800 US Highway 301, Dade City, Florida 33523.

ARTICLE III - PURPOSE
