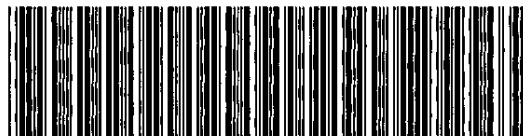

The undersigned hereby submits these Articles of Incorporation for the purpose of forming a not for profit corporation under the laws of the State of Florida:

1. The name of the corporation is: Fill The Gap Project, Inc.
2. The address of the initial place of business, mailing address, and the initial registered office of the corporation in the State of Florida is: 12200 W. Colonial Drive, Suite 300F, Winter Garden, FL 34787.
3. The purpose for which the corporation is organized is educational. The corporation is to promote the development and use of educational products that make use of digital devices and Internet infrastructure to further learning processes.
4. Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
