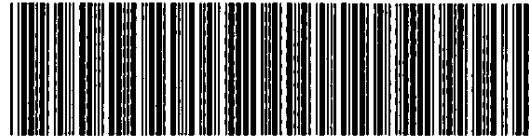

Articles of Incorporation of
World Change Alliance, Inc.

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

Article I - Name

The name of this corporation shall be: **World Change Alliance, Inc.**

Article II - Principal Office

The principal street address of this corporation is:

**1015 Indigo Drive
Celebration, FL 34747**

Article III - Purpose

This corporation is organized exclusively for charitable purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purposes for which this corporation is organized are:

- a) To provide an easy, automatic mechanism for kind-hearted people (benefactors) to donate spare change to IRS-approved 501(c)(3) charities to which they feel a deep personal connection.
- b) To provide custom-designed software applications that enable registered charitable benefactors an easy means to support and fund chosen benevolent organizations by rounding up their credit card transactions.

Article IV - Manner of Election

The manner in which the directors are elected and appointed: as provided for in the bylaws.

Article V - Initial Officers and/or Directors

The number of initial directors of this corporation shall be **four (4)**.

The number of directors may be increased from time to time in the manner provided for in the bylaws. However, the number of directors will never be less than four (4) and no more than twelve (12).

Article VI – Registered Agent

Article VIII

The period of duration of this corporation is **perpetual**.

Article IX

There will be no members of this corporation.

Article X

Additional Provisions:

The property of the corporation is irrevocably dedicated to charitable purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
