Articles of Incorporation Continuation of Article III Barkin for a Park, Inc.

## ARTICLE III PURPOSE

The purpose for which the corporation is organized is: <u>exclusively for</u> <u>charitable</u>, <u>religious</u>, <u>educational</u> and <u>scientific purposes including the</u> <u>making of distributions to organizations that qualify as exempt organizations under section 502(c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax codes.</u>

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; or shall be distributed to the federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s), as said court shall determine are organized and operated exclusively for such purposes.
