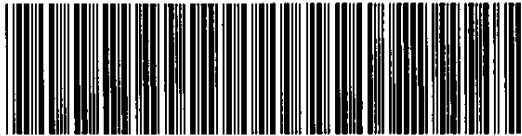

Of

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a not for profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE I - NAME

The name of the corporation shall be Fenaz Community Center, Inc.

Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
