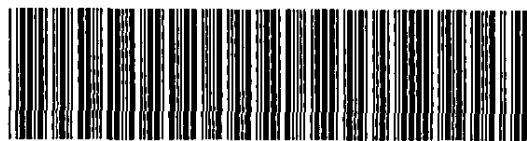

Articles of Incorporation

in compliance with Chapter 617, F.S. (Not for Profit)

Article I Name:

The name of the corporation shall be: New Chorale of Southwest Florida, Inc.

Article II Principal Office:

28700 Pienza Ct., Bonita Springs, FL 34135

Article III Purpose:

The specific purpose of the corporation is to bring musical entertainment and pleasure to its members and to others. Dues and contributions will be accepted to fund activities. The Corporation will operate exclusively in a manner which will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the contributions to organizations qualified as tax exempt organizations under the Internal Revenue Code. Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any subsequent United States Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

Article IV Membership & Manner of Election:

Membership shall be open to all persons interested in music. Officers and Directors shall be elected, vacancies filled and new positions created as provided in the By-laws.

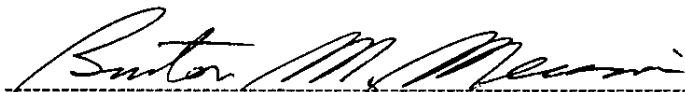

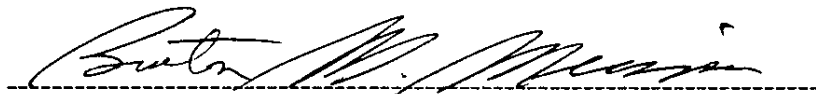
