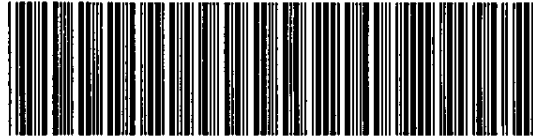



1. The following provisions of the Articles of Incorporation of DFH Wildwood Homeowners Association, Inc., a Florida corporation, filed in Tallahassee on November 13, 2013, be and they hereby are amended in the following particulars:

A. Article I hereby is amended to read as follows:

"The name of the corporation is The Preserve at Wildwood Homeowners Association, Inc."

2. Article VII Section 2 hereby is amended to read as follows:

"Section 2. Class B Voting: The class B members shall be entitled to seven (7) votes for each residential lot owned. Upon conversion of the Class B membership as provided in the Declaration of The Preserve at Wildwood, each Lot owned by the Developer shall have one (1) vote per lot. In addition, until such a time as the class B membership is converted to class A membership, the class B membership shall have a right of veto on all questions coming before the membership for a vote on it.

3. The foregoing amendment was adopted by the Board of Directors of the Corporation on the 24<sup>th</sup> day of March, 2014. There are no members entitled to vote on the amendment.
