

- The following provisions of the Articles of Incorporation of DFH Wildwood Homeowners

 - A. Article I hereby is amended to read as follows:

"The name of the corporation is The Preserve at Wildwood Homeowners Association, Inc."

- "Section 2. Class B Voting: The class B members shall be entitled to seven (7) votes for each residential lot owned.
