**ARTICLES OF INCORPORATION
OF
NEW CITY CHURCH, PALM BEACH GARDENS, INC.,
a Florida corporation not for profit**

The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for the corporation:

ARTICLE I
(Name)

The name of the corporation is New City Church, Palm Beach Gardens, Inc.

ARTICLE II
(Duration)

The corporation shall have a perpetual duration.

ARTICLE III
(Authority)

The corporation is organized pursuant to the laws of the State of Florida. The form of church government is provided for by The Book of Church Order of the Presbyterian Church in America. The governing body is therein provided as the Session. The Board of Directors provided for by these Articles of Incorporation shall perform all corporate powers necessary and as required by the State of Florida.

Unless otherwise provided for by the laws of the State of Florida, any conflict between these Articles of Incorporation and The Book of Church Order of the Presbyterian Church in America shall be resolved in favor of The Book of Church Order.

ARTICLE IV
(Purposes)

The corporation is organized exclusively for religious, educational and charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code (or any corresponding provision of any United States Internal Revenue law), and such purposes shall include, but not be limited to, the following:

1. To be a growing Christian fellowship glorifying God in worship, nurturing people in Biblical faith, and spreading the gospel of Jesus Christ throughout our community and into the world; and

2. To do everything necessary, suitable or proper for the accomplishment, attainment or furtherance of the purposes, objects or powers set forth in this Articles of Incorporation, whether alone or in association with others and to possess all rights, powers and privileges now or hereafter conferred by law upon a not for profit corporation organized under the laws of the State of Florida.

ARTICLE V (Directors)

The number, method of election, qualifications and term of each member of the Board of Directors shall be established by the Bylaws.

ARTICLE VI (Initial Directors)

The initial Board of Directors shall consist of three (3) members. The names and addresses of the persons to serve as the initial directors, who shall serve until a successor is elected as set forth in the Bylaws, are as follows:
