ARTICLES OF AMENDMENT

of

DFH GREYHAWK HOMEOWNERS ASSOCIATION, INC.

N13000009942

1. The following provisions of the Articles of Incorporation of DFH Greyhawk Home Owners Association, Inc., a Florida not-for-profit corporation, filed in Tallahassee on November 4, 2013, be and they hereby are amended in the following particulars:

A. Article I hereby is amended to read as follows:

"The name of this corporation shall be Grey Hawk Estates Home Owners Association, Inc.

B. Article VII Section 2 hereby is amended to read as follows:


Section 2. Class B Voting: All class B Members shall be entitled to Eight (8) votes for each Lot owned. Upon conversion of the Class B membership to Class A membership at turnover of the Association, the former Class B Members shall have one vote per Lot owned. In addition, until such a time as the class B membership is converted to Class A membership, the Class B membership shall have a right of veto on all questions coming before the membership for a vote.

2. The foregoing amendment was adopted by the Board of Directors of the Corporation on the 5th day of December, 2014. There are no members entitled to vote on the amendment.

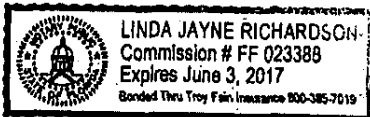

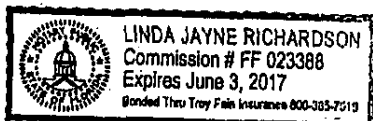
