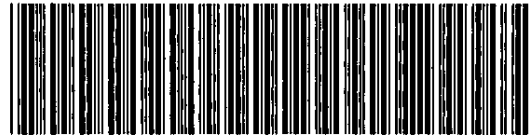

ARTICLES OF INCORPORATION

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of incorporation.

I. Name

Name of the corporation shall be:

II. Purpose

1. Purpose for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1986 or the corresponding provision of any future Internal Revenue Law.
2. To provide assisted living for elderly clients that have been diagnosed with Alzheimer's or dementia.
3. To educate and promote client and families in the area of safety in a homelike environment.
4. To perform other as needed.

III. Principle Place of Business shall be located as follows:

**IV. Life of Corporation**

Life of the corporation shall be perpetual unless dissolved by an act of law or Board of Directors.

**V. Bylaws**

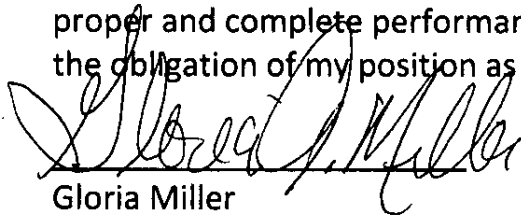

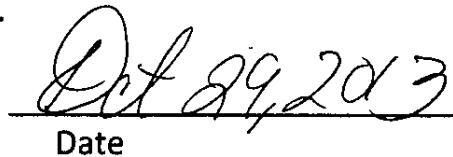
