Article III - Purpose is amended as follows:

Article III - Purpose

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation seeks to create a continuing legacy that will generate financial recourses to fund worthy projects to meet the mission and goals of the Rotary Club of St. Augustine within the immediate geographic area of St. Augustine, Florida.

Notwithstanding the foregoing or any other provision of these Articles of Incorporation, the corporation shall not at any time engage in a regular business of a kind ordinarily carried on for profit, nor shall any part of its net earnings inure to the benefit of any member or individual, nor shall it perform particular services for any member or individual, nor shall it engage in any transaction which would cause it to be denied the status of any organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX - Dissolution is added as follows:

Article IX - Dissolution

Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
