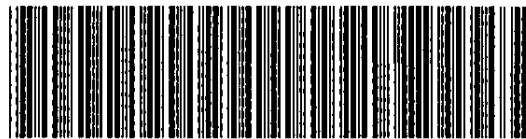

**The purposes for which this Corporation is formed are:**
