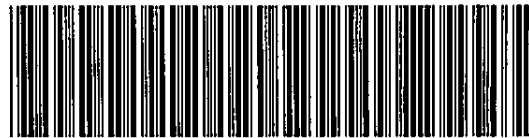

The corporation's assets shall be exclusively dedicated to an exempt purpose within Internal Revenue Code 501 (c)(3). Notwithstanding any other provision of this document, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in the furtherance of the purposes of this corporation.
