Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or shall be distributed to such other organization or organizations which are organized and operated exclusively for such purposes, or shall be distributed to the Federal government, or to a state or local government for public purpose.
