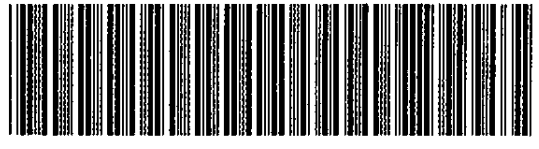

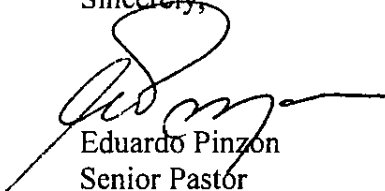

#### **ARTICLE IX – DISSOLUTION**

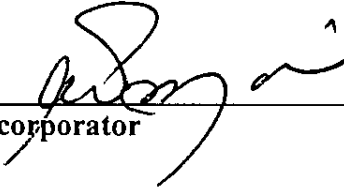

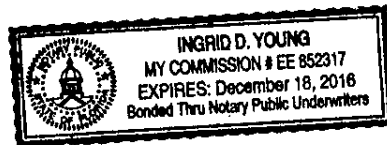
