Articles of Incorporation of

American Community of Georgians Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: 1. creating home or safe locations for people who migrated from country of Georgia voluntarily or forced to America 2. Creating a collective identity to combine people each other by reference of historical experience and to the to a geographic place. 3. Maintaining a variety of explicit and implicit ties with their homelands and founding communications and relationship with not only their homelands but also other foundations in other countries 4. Developing solidarity with co-ethnic members in other countries of settlement. 5. To provide people to cope with feelings of alienation, exclusion, superiority or other kind of difference or distinction. 6. To introduce their own cultural features and specialties to host-people & country of USA. 7. To make propaganda about their missions and national aims and ideals via newspapers, TV channels and journals.

In addition, American Community of Georgians can help and support their populations financially via some foundations or charities. In some days which have important roles, our NGO will organize some activities by the way they supplement to strengthen bonds of brotherhood. Our NGO will prepare suitable social environment for people encountering cultural shock in foreign countries. They make up new consciousness because the features of culture, trends and social attitudes are changed when people migrate and settle new homes. This is an important point for new settlers in foreign places because many people migrating to foreign countries absolutely encounter cultural shock and they can not adapt themselves to foreign cultures in first times.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
