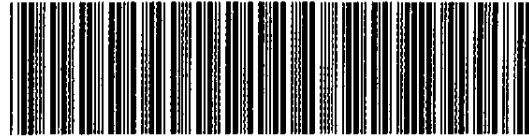

**Article 1.**     **Name.** The name of the Corporation is **Illumination Christian Church, Incorporated.**

**Article 2.**     **Principal Office.** Illumination Christian Church, Incorporated is located at 1469 North Magnolia, Suite F, Unit 4, Ocala, Florida, 34474. The mailing address for the Corporation is 1035 NE 13<sup>th</sup> Street, Ocala, Florida, 34470.

**Article 3.**     **Purposes.** The purpose of the Corporation is as follows:

- A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is to help hurting and discouraged people find hope through God's only hope for man which is Jesus Christ.
- B. To exercise all rights and powers conferred by the law of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

**Article 4.**     **Manner of Election of Directors.**

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.
