These Articles of Amendment of La Fofi's Rainbow Foundation, Inc., a Florida not for profit corporation (the "Corporation"), are made as of this 24 day of Hack 2015. The original Articles of Incorporation were filed with the Department of State of the State of Florida on December 2, 2013. Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida not for profit corporation adopts the following amendments to its Articles of Incorporation:

1. Article III shall be deleted and the following substituted in its place:

### "ARTICLE III Purpose

La Fofi's Rainbow Foundation, Inc., was founded by Betzaida "Betsy" Guerra and her husband Alain after they suffered the loss of a child at the tender age of two. Betsy, Alain and the entire Guerra family lived through that terrible event only with the wonderful help of family and friends and the prayers of the community. Betsy and her family, along with countless friends who are practically family, wanted to make sure that others suffering the pain and heartache of the death of a child, the terminal illness of a child or the diagnosis of a life threatening disease of a have that same type of support whenever possible.

The purpose La Fofi's Rainbow Foundation, Inc., is to provide that comfort and support to families in need that are suffering from the death of a child or a child or children with terminal, chronic or life-threatening diseases or with severe debilitating physical problems and disabilities. Its goal is to help relieve some of the day -to -day tension, stress, and complications that result from these crises they are in and provide moral and emotional support and hope and promoting faith. Their team accompanies the family with a great sense of empathy and solidarity in their process and helps them undergo the adaptation and transitions that are exacerbated by these problems. It is not a one-time deed, but rather a sort of "adoption" of the family while they go through their crisis. During the process, their needs are defined, met, and redefined as new circumstances arise. The services provided are divided into categories using the colors of the rainbow, each of which is led by a team member responsible for meeting the family needs in that particular area.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objectives."

2. Article VII shall be deleted and the following substituted in its place:

#### "ARTICLE VII Dissolution

Upon a dissolution of the Corporation, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Code, or to the federal, state, or local government for exclusive public purpose."

3. Article VIII is added to read as follows:

## "ARTICLE VIII Limitations

- Section 1. <u>Legislative and Political Activity</u>. No substantial part of the activities of the Corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements in connection with) any political campaign on behalf of or in opposition to any candidate for public office.
- Section 2. <u>Property.</u> The property, assets, profits, and net income of the Corporation are dedicated irrevocably to the purposes set forth herein. No part of the Corporation's profits or net earnings shall inure to the benefit of its directors, officers, members, or to the benefit of any private individual.
- 4. This amendment was approved by the directors on March  $\frac{34}{4}$ , 2015, because the Corporation has no members, and (2) the number of votes cast by the directors for the amendment was sufficient for approval
