PROPOSED AMENDMENTS

TO THE

ARTICLES OF INCORPORATION OF BENT CREEK PRESERVE HOMEONWERS ASSOCIATION, INC.

Additions are <u>underlined</u>. Deletions are stricken through.

Article IX of the Articles of Incorporation is hereby amended as follows:

The affairs of the Association shall be managed by a Board of odd-number-with not less than three (3) nor more than five (5) members. The current number of directors shall be three (3) Board members and have been appointed as stated in the By-Laws. The election of Directors by Members other than Developer shall initially be held on the date the Developer no longer has the legal right pursuant to the Declaration to appoint-Directors, and thereafter at the Annual Members Meeting. Directors shall be elected for a terms as designated in the Bylaws. expiring on the date of the next Annual Meeting.
