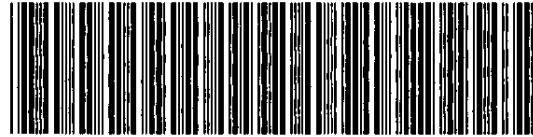

**ARTICLE I. NAME OF CORPORATION.** The name of the corporation shall be, "A.J.I. Design, Inc." (hereinafter referred to as, "the Corporation" or "A.J.I. Design, Inc.")

**ARTICLE II. PRINCIPAL OFFICE.** The principal street address for the Corporation is: 200 Scotia Drive, Unit #303, Hypoluxo, Florida 33462.

**ARTICLE III. PURPOSE.** The Corporation, A.J.I Design, Inc., is organized to empower persons with disabilities by giving them a means of supporting themselves financially as they use their talents and abilities in the area of graphic and web design to provide personal, quality service and products such as tee-shirts, banners, flyers and other means of advertising and marketing materials to the public.
