Articles of Incorporation Of

Article 1.

The name of the corporation is Getting Back The Religious Precepts, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 7950 NW 53rd St, Suite 337, Miami, FL 33166. The initial registered agent of the Corporation at such address shall be: Martha D. Lopez.

Article 3.

The name and address of the incorporator is:

Article 4.

The Corporation will not have Members.

Article 5.

The initial principal office address of the Corporation shall be at: 7950 NW 53rd St, Suite 337, Miami, FL 33166.

Article 6.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose of the organization is to spread the Gospel.

Article 7.

(including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
