ARTICLE I NAME

ARTICLE II PRINCIPAL ADDRESS

ARTICLE III EXEMPT STATUS

The Corporation is formed in order to attract substantial support from contributions, directly or indirectly, from a representative number of persons in the community in which it operates and has not been formed for pecuniary profit or financial gain. No part of the assets, income, or profit of the Corporation is distributable to, or inures to the benefit of, its Directors or Officers, except to the extent permitted under the Florida Not for Profit Corporation Act.

ARTICLE IV PURPOSE

The Corporation is formed for charitable purposes within the meaning of §501(c)(3) of the Code to be a public charity which raises funds to be used for children with cancer who may need emotional support and whose parents need financial support to pay the cost of hospital bills and transportation, in the public and private sector and for related public purposes. The Corporation may do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its Directors or Officers, except as permitted under the Florida Not for Profit Corporation Act. In furtherance of its corporate purposes, the Corporation shall have all general powers enumerated in §617.0302 of the Florida Not for Profit Corporation Act.

ARTICLE V DURATION

This corporation shall have perpetual existence.
