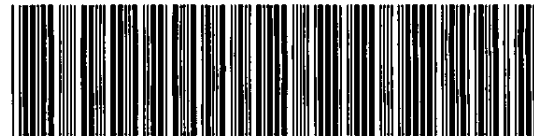

PURPOSE**


