ARTICLE I - NAME

The name of the corporation shall be: **UNITED STATES SOCCER 7 ASSOCIATION, INC.** (the "Corporation"). Said corporation is organized exclusively for charitable, educational and scientific purposes including for such purposes the making of distributions to organizations under section 501 (C) (3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

ARTICLE II – PRINCIPAL OFFICE

The street address of the initial principal office of the Corporation shall be 917 SW 143rd Avenue, #1705, Pembroke Pines, FL 33027.

ARTICLE III – PURPOSE

This corporation was specifically created to develop, promote and administer soccer 7 (seven) clubs catering to youths, adults, both professionals and non-professionals within the community.

The corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501 (C) (3) purposes.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code or to another similar exempt organization for a public purpose.

ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected and appointed will be as provided for in the bylaws.


