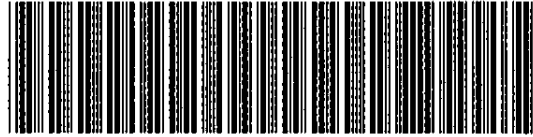

ARTICLES OF INCORPORATION

ARTICLE I

FATHERS IN FAMILIES, INCORPORATED

As a Florida Non-profit Public Charity and Educational Corporation

ARTICLE II

PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III

PURPOSE

FATHERS IN FAMILIES is a non-profit organization established exclusively to provide public charitable and educational purposes within the meaning of Section 501©3 of the Internal Revenue Code.

Section 3.01 Its purpose is to bring Support Groups and Family and Couples therapy to provide referred and volunteer fathers the skills to return to their families. Their newly nurturing and responsible qualities can enable them to turn around long intergenerational cycles of negativity and dependence.

Section 3.02 The highly confidential groups often follow Parenting and Anger Management Classes in encouraging the behavioral changes these classes propound. These relationship oriented transformations are brought about through the coaching of a long experienced Licensed Marriage and Family therapist who helps the men, primarily through role playing where they take turns with others, to really experience how destructive their communication can be heard and seen by others, especially the mother of their children who has often been felt neglected and hurt in the past.

Section 3.03 Currently, fathers are being referred by the local Department of Children and Families, courts, churches and by word of mouth for these changes which can reduce or lift past court involvement, allowing the men to see more of their children and return home.

Section 3.04 To do all this, FATHERS IN FAMILIES will train group therapists and co-facilitators to run such groups we establish within many sites throughout the county, and perhaps, elsewhere, especially within churches and transitional housing centers.

Section 3.05 Through specifically focused Celebrations of Fathers, especially on Father's Day, it hopes to bring a focus on the very important place these so transformed fathers can have in their families, so alleviating their marginalization that now takes place through their expanding dependence upon both public and private financial support.

ARTICLE IV

MANNER OF ELECTION

Directors are referred by other Members of the Board. After they are vetted and determined appropriate by the Nominating Committee, they are elected by a majority vote.
