# ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

#### LUV ALL CREATURES ANIMAL HOSPITAL, CORP.

(Not for Profit Corporation)

The following provisions of the Articles of Incorporation are amended in the following manner:

Article III of the Articles of Incorporation shall be amended by adding the following language:

The corporation is organized exclusively for charitable, religious, educational and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Article IV of the Articles of Incorporation shall be deleted and replaced with the following language:

Directors shall be elected and appointed in the manner prescribed in the Bylaws, as may be adopted by the Corporation.
