## Articles of Incorporation of

#### Job Connect Professionals, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Qualified Employment Specialists will assist unemployed & disabled individuals in need of employment, with community jobs, by networking & educating employers as to the benefits of hiring disabled individuals that meet all the requirements of available positions. Employment Specialists will also assist in resume writing, interview preparation, provide guidance & resources as needed. Initial clients will reside in Brevard County, Florida, with an extension into additional Florida counties as professional support become available. Additional option to have clients nationally, where qualified employment specialists meet the local criteria & clients are in need of this service. Clients will be reached through references provided by Vocational Rehab counselors, and through the Ticket To Work program through the Social Security Administration.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
