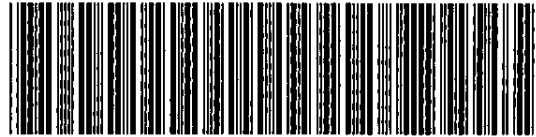

The purpose for which the corporation is organized is: To generate funds and support for charitable trusts and causes through fundraising in annual music festivals, combining musicianship and the creative arts. Said organization is being organized exclusively for these charitable purposes, including, for such purpose, the act of distributing funds to such non-profit organizations and trusts that fall under the 501 (c) (3) Internal Revenue Code, and/or the corresponding section under any future federal tax code. All earnings and donations acquired for such events and from such events shall in no way be redistributed to its members, private companies, or private persons, unless in the case of compensation for services to the corporation that further the purpose for which the corporation is formed.  
In the event of the termination of the corporation, under the meanings of 501(c) (3), all remaining assets shall be dissolved for one or more exempt purposes, including to that of another charity or trust, or to the federal/state government. Any funds not so properly dissolved shall be handled by the Court of Competent Jurisdiction in the county where the corporation was formed.

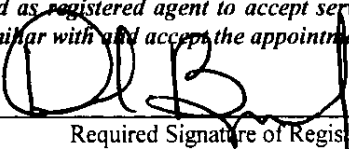

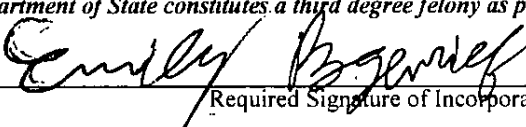
