

Article III.Purpose

Just Choices, Inc. provides temporary sheltered housing and services to people who are endangered, homeless, destitute or suffering from extreme or abusive situations. The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the internal revenue code and corresponding section of any future federal tax code. Upon dissolution of the organization, the assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the internal revenue code or corresponding section of any future federal tax code or shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes, or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

Article VIII Effective Date

The effective date of the Corporation shall be December 6, 2013.
